RELEASE AND WAIVER OF LIABILITY

The United Way of Greater Toronto (the "United Way") has organized and will run the Scotiabank Rat Race for United Way (the "Event") on Thursday, June 16, 2011. The Event is a 5-kilometer run through downtown Toronto with pre and post celebration activities taking place at Scotia Plaza – 40 King Street West. I know that the Event involves physical activity and I voluntarily assume the risk of participating in the Event. In return for my being permitted to participate in the Event, I agree to the terms of this release and waiver of liability (the "Release"). I sign this Release on behalf of myself, my heirs, executors, administrators, successors, and assigns (the "Releasers"). If I am signing this Release as a parent or guardian of a child/children under 18 years of age participating in or attending the Event, I have considered whether the Event is appropriate for the child/children. I take full legal responsibility for permitting the child/children to participate or attend and I also sign this Release on behalf of the child/children, each of whom is also a Releaser. According to the terms below, the Releasers release all of the following parties, which together are referred to as the "Released Parties": (a) United Way and its officers, employees, servants, directors, members, volunteers, insurers, and Board of Trustees; (b) United Way's agents, sponsors, and organizers for this Event including the City of Toronto, The Toronto Police Services Board, and Toronto Police Service, the Members of the Toronto Police Service Auxiliary Program, the Chief of Police, Scotia Plaza, the Toronto Transit Commission, Bank of Nova Scotia, Rocklyn Event Planning limited and their officers, employees, servants, directors, members, volunteers, and insurers; and (c) any other person or organization assisting in the Event. I agree that the Releasers will make no demand or claim against the Released Parties for death, injury, damages, or loss ("Damage") related in any way to the Event that I suffer before, during, or after the Event, whether as a spectator or participant in the Event and no matter how the Damage occurs or who causes the Damage. I also agree that this Release will be effective even if one or more of the Released Parties causes or contributes to the Damage by fault or negligence. I agree that the Releasers will make no demand or claim against any other person who could claim against the Released Parties for the matters this Release covers. I also agree that the Releasers will indemnify the Released Parties against any claims, demands, or costs connected with any Damage others or I suffer arising from my participation in the Event, even if one or more of the Released Parties causes or contributes to the damage by fault or negligence. I understand that the party receiving this release receives it on behalf of every Released Party and that the United Way's permission for me to participate in the Event is given by each Released Party in return for this Release.

Photo, video, audio, film, interview release: Also in return for being permitted to participate in the Event, I consent to the use of my name, city and province of residence, likeness, statements, biographical information, voice, voice likeness, and the taking, use or publication of any photograph, video, audio, or video and audio recording of me by or on behalf of United Way or its advertising and promotional agencies in all forms of media whatsoever, including newspapers, magazines, radio, television, DVD, film and the Internet now or hereafter known throughout the world in perpetuity without further compensation, permission or notification. I agree that United Way is the owner of any such photograph, video, audio, or video and audio recording.
